This Order is made by The East Riding of Yorkshire Council ("the Council") under section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that, having regard to the matters set out in section 26(1), there is a need for a public footpath over the land to which this Order relates, and that it is expedient that the way should be created.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the Authority that the Humberside County Council East Yorkshire Borough of Beverley Definitive Map and Statement of Public Rights of Way require modification in consequence of the occurrence of an event specified in section 53(3)(a)(iii) of the 1981 Act, namely, the creation (as authorised by this Order) of a public footpath.

Lockington Parish Council have been consulted as required by section 120(2) of the 1980 Act.

**BY THIS ORDER:**

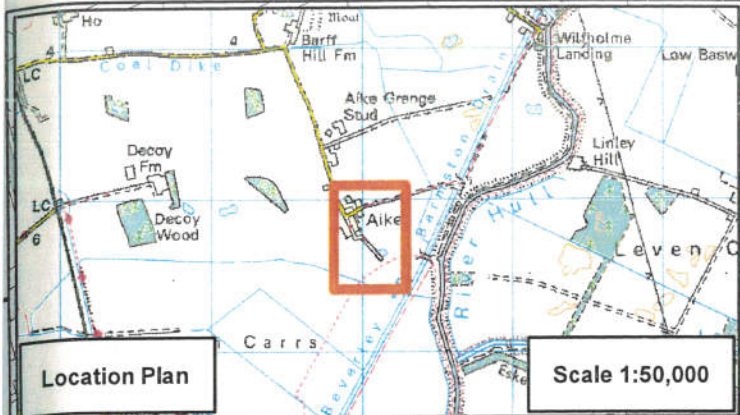
1. There shall be at the end of seven (7) days from the date of confirmation of this Order a public footpath over the land in the parish of Lockington described in the Schedule to this Order and shown by a bold broken line on the map attached to this Order, and thereupon the Humberside County Council East Yorkshire Borough of

Beverley Definitive Map and Statement of Public Rights of Way shall be modified by adding that public footpath to it, and the definitive statement shall be modified as described in Part 2 of the Schedule to this Order.

2. For the purposes of this Order the relevant date is the date upon which the Order comes into effect.

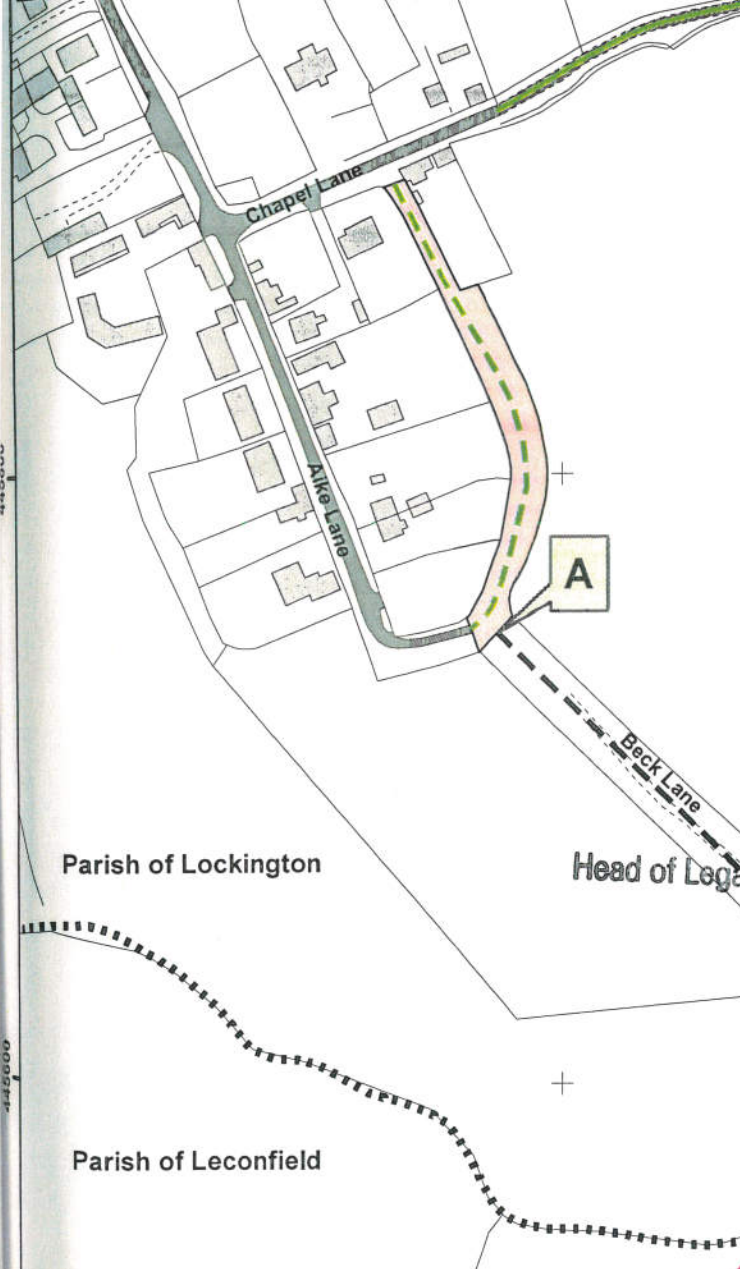

### PART 1

#### DESCRIPTION OF LAND

A section of footpath some 215 metres in length commencing on Lockington Restricted Byway No. 15 at Grid Reference TA 0498 4574 (Point A on the Map) and leading south-easterly for some 165 metres then south-south-easterly for some 50 metres to join Leconfield Footpath No. 30 at Grid Reference TA 0511 4558 (Point B on the Map).

The width of the footpath will be 4 metres.
