This Order is made by The East Riding of Yorkshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to that authority that the Humberside County Council Borough of Holderness Definitive Map and Statement of Public Rights of Way require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) of the Act, namely the discovery by the authority of evidence which (when considered with all other evidence available to them) shows that two rights of way which are not shown in the map and statement subsist or are reasonably alleged to subsist over land in the area to which the map relates, being rights of way such that the land over which the rights subsist are public footpaths.

The authority have consulted with every local authority whose area includes the land to which the Order relates. The East Riding of Yorkshire Council hereby order that:

1. For the purposes of this Order the relevant date is 30<sup>th</sup> April 2021.
2. The Humberside County Council Borough of Holderness Definitive Map and Statement of Public Rights of Way shall be modified as described in Part I and II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The East Riding of Yorkshire Council (Skirlaugh Footpath Nos. 5 & 6) Definitive Map and Statement Modification Order 2021.

PART 1

MODIFICATION OF DEFINITIVE MAP

Description of path or way to be added

- a) A public footpath in the parish of Skirlaugh some 57 metres in length commencing on Poplar Close at Grid Reference TA 1416 3960 (Point A on the Map) and leads south-south-easterly to join Church Lane (B1243) at Grid Reference TA 1419 3955 (Point B on the Map).

The footpath will have a width of 1.74 metres (A-E) and 2.4 metres (E-B).

- b) A public footpath in the parish of Skirlaugh some 91 metres in length commencing on Main Road at Grid Reference TA 1412 3956 (Point C on the Map) and leads east-north-easterly to join Church Lane (B1243) at Grid Reference TA 1421 3959 (Point D on the Map).

The footpath will have a width of 3.0 metres.

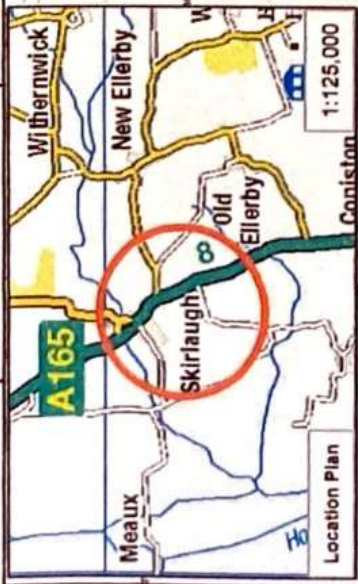
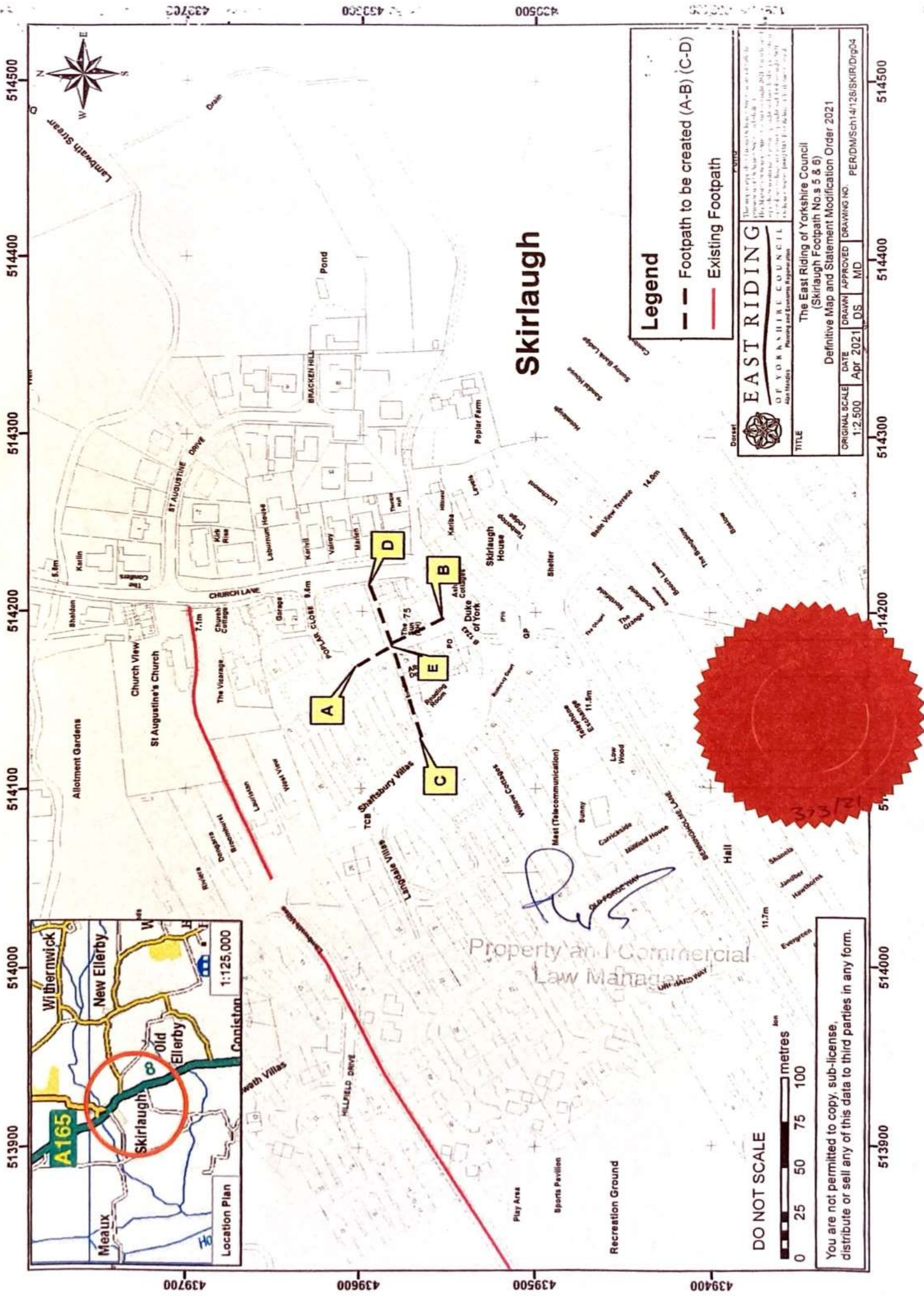
