The public right of way over the land situated at Woodmansey in the East Riding of Yorkshire shown by a continuous bold line on the map attached to this Order and described in Part I of the Schedule to this Order shall be extinguished after seven (7) days from the date of confirmation of this Order.

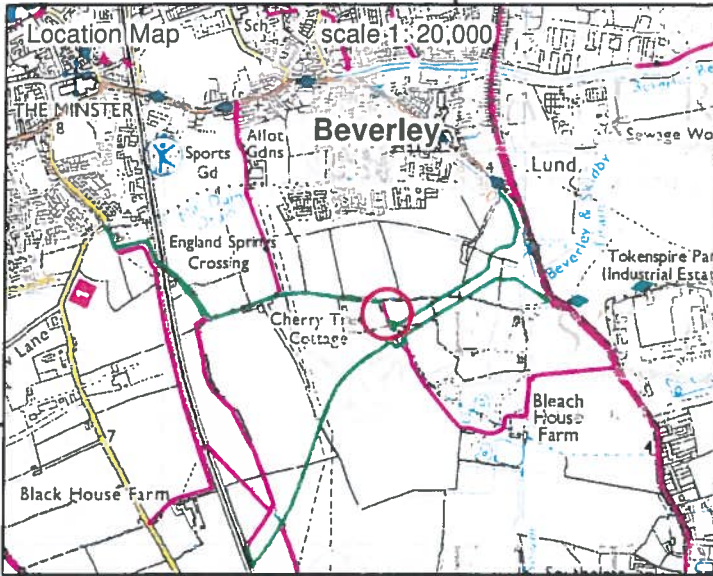

Path to be extinguished

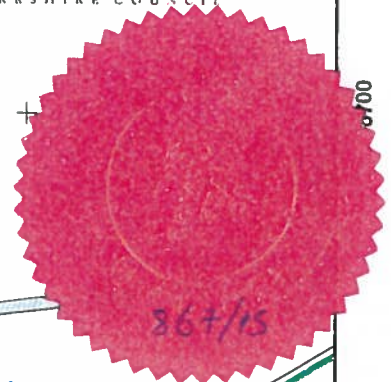
