PUBLIC PATH CREATION ORDER 2015

This Order is made by The East Riding of Yorkshire Council ("the Council") under section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that, having regard to the matters set out in section 26(1), there is a need for a public bridleway over the land to which this Order relates, and that it is expedient that the way should be created.

Woodmansey Parish Council have been consulted as required by Section 26(3) of the 1980 Act.

BY THIS ORDER:

There shall be at the end of seven (7) days from the date of confirmation of this order a public bridleway over the land in the parish of Woodmansey described in the Schedule to this Order and shown by bold broken line on the map attached to this Order.

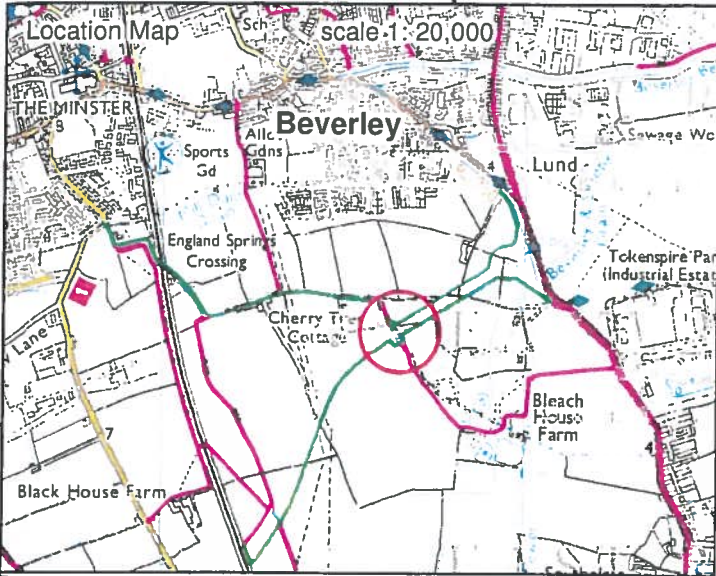
SCHEDULE

DESCRIPTION OF LAND

A section of bridleway in the parish of Woodmansey some 72 metres in length commencing at the eastern end of Bridleway No. 15 at Grid Reference TA 0460 3865 (Point A on the Map) and leading south-south-easterly to the northern boundary of Minster Way at Grid Reference TA 0463 3859 (Point B on the Map).
