This Order is made by The East Riding of Yorkshire Council under section 53(2)(a) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to the authority that the Humberside County Council East Yorkshire Borough of Beverley Definitive Map and Statement of Public Rights of Way require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) of the Act, namely the discovery by the authority of evidence which (when considered with all other evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the rights subsists is a restricted byway.

The authority have consulted with every local authority whose area includes the land to which the Order relates. The East Riding of Yorkshire Council hereby order that:

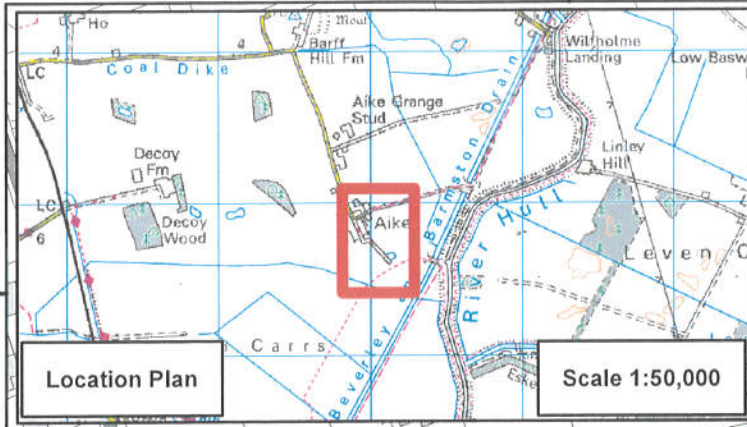
1. For the purposes of this Order the relevant date is 19 December 2017.
2. The Humberside County Council East Yorkshire Borough of Beverley Definitive Map and Statement of Public Rights of Way shall be modified as described in Part I and II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The East Riding of Yorkshire Council (Lockington Restricted Byway No. 15) Definitive Map and Statement Modification Order 2018.

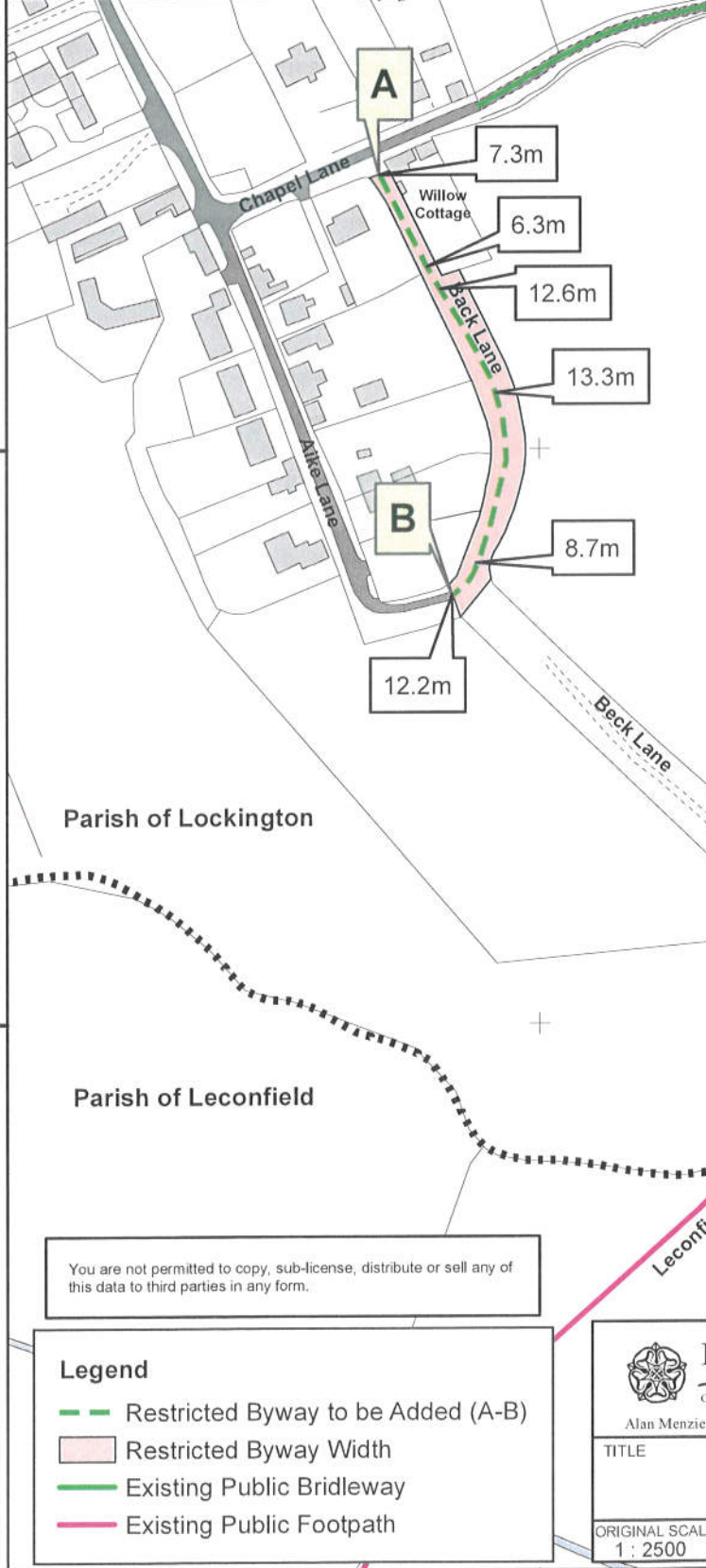

PART 1

MODIFICATION OF DEFINITIVE MAP

Description of path or way to be added

- a) A restricted byway in the parish of Lockington some 160 metres in length commencing on the southern side of Chapel Lane west of Willow Cottage at Grid Reference TA 0494 4589 (Point A on the Map) and leading south-south-easterly then south-south-westerly to join Aike Lane at Grid Reference TA 0496 4574 (Point B on the Map).

The restricted byway will have a variable width between 6.3 metres and 13.3 metres as shown shaded pink on the Map.
